## LEARNING PROGRAMME CONTENT

The Learning Programme provision shall comprise of three mandatory elements:

- Qualifications,
- Essential Skills
- On/off the job training

The total minimum credit value required for the Level 2 Pathway  
Level 2 Beauty Therapy - General is 78 credits.

The total minimum credit value required for the Level 3 Pathway  
Level 3 Beauty Therapy – General is 63 credits.  
Level 3 Beauty Therapy – Make Up is 69 credits  
Level 3 Beauty Therapy – Massage is 83 credits

The total minimum credit value required for the Level 4 Beauty Therapy  
Level 4: Advanced Beauty Practices – Advanced Beauty Practitioner is 87 credits

## ENTRY REQUIREMENTS

### Level 2

There are no nationally agreed minimum entry requirements or previous experience requirements, but the following selection criteria may be used as guidance.

Because the industry has high client expectations and relies on repeat business importance is given to:

- Appropriate personal presentation including clothing, hair and personal hygiene.
- Practical, organisational and social skills.
- Attention to detail and cleanliness.
- An empathetic and amicable nature with effective communication skills.
- Willingness to work flexible hours/days as agreed in the employment terms and conditions.
- Physical and emotional resilience
- A high degree of dexterity and coordination.
- Potential apprentices with a predisposition to certain skin conditions or allergies, such as occupational dermatitis, eczema or asthma, need to understand that some of the products, chemicals, and formulations used in Beauty Therapy may have significant effects on their health.

Apprentices must always be interviewed by their potential employer and training provider. They may deem enthusiasm and passion for the subject to be more important than formal qualifications. It is for this reason that the Hair and Beauty Sector has chosen not to be overly prescriptive about entry requirements.

It is advantageous to have had previous experience of working within the Beauty Therapy, barbering or hairdressing industry.

It is advantageous to have three GCSEs Grade D or above in English and/or Welsh, Maths, Science or Art.

### Level 3

In addition to the entry requirements for Level 2, Apprentices wishing to undertake the level 3 pathway should ideally have a relevant Level 2 qualification in Beauty Therapy, if undertaking the Level 3 Beauty Therapy Apprenticeship.

### Level 4:

In addition to the entry requirements for Level 2 & Level 3, Apprentices wishing to undertake the Level 4 pathway should ideally have substantial relevant vocational experience, however candidates with one year experience can be considered at the discretion and agreement of the employer and the training provider.

Entry to the beauty pathway at this level requires the apprentice to have completed a level 3 or be able to prove this level of competence with appropriate industry experience (Level 3 Modern/Advanced Apprenticeship in Beauty Therapy (Level 3 S/NVQ or VRQs in Beauty Therapy or equivalent).

It is recommended that all candidates should be employed, for minimum of 30 hours per week gaining new skills, knowledge and behaviours.

Higher Apprenticeship In Advanced Beauty Practices (L4) 634 hrs completed within a minimum of 12 months (off: 258 hours and on: 376hrs)

## PROGRESSION

## **Level 2 –Beauty Therapy**

Progression into:

- From a preparation for work, non-competency based qualification in Beauty Therapy.
- From the Foundation or Intermediate Level Welsh Baccalaureate Principal Learning in Hair and Beauty Studies.
- Following a Level 1 Beauty Therapy programme.
- Direct entry from school or college.
- Direct entry from another occupation.

Progression from:

- To the Advanced Level Welsh Baccalaureate Principal Learning in Hair and Beauty Studies.
- To the Level 3 Beauty Therapy apprenticeship programme.
- Into employment as a junior beauty therapist or junior nail technician or other job roles in the beauty related industries.

## **Level 3 - Beauty Therapy**

Progression routes into:

- From a preparation for work, non-competency based qualification in Beauty Therapy.
- From the Advanced Level Welsh Baccalaureate qualification Principal Learning in Hair and Beauty Studies.
- Following completion of Level 2 in Beauty Therapy or Nail Services undertaken via either an apprenticeship (not available in Spa Therapy) or a full time college based programme.

Progression from:

- Into employment as a beauty therapist, nail technician or spa therapist or other job roles in the beauty related industries.
- Into higher education such as a Foundation degree in Beauty Therapy and Salon Management or other programmes.

## **Level 4 - Beauty Therapy**

Progression routes into:

There are no pre-defined entry routes, however learners wishing to progress into this apprenticeship programme could come from a variety of backgrounds with a variety of qualifications or equivalent experience but definitely a passion for working in the sector.

Learners might be already working in a level 3 beauty therapy role, managing, owning salons and/ or spas who were high performing learners or who have shown a high level of self development therefore wish to further develop their understanding and practice in the sector in order to enhance the services offered.

The expectation is that regardless of the background of the learner, they will come with years of salon experience and practice.

Progression from:

Learners may wish to progress from their apprenticeship through a variety of routes.

Learners can progress with a promotion within salons, either within salon groups or new employers. They can also get involved in franchising, and becoming employers themselves.

On completion of this pathway, learners can also progress with their studies to higher level management qualifications.

Others will gain creative confidence working on main stage presentation and in training or gain employment as a salon assessor or team leader.

Learners can also progress onto working with / for various Skin and Body care companies.

## EQUALITY & DIVERSITY

It is important that apprenticeship Pathways are inclusive and can demonstrate an active approach to identifying and removing barriers to entry and progression. Pathways should advance equality of opportunity between persons who share protected characteristics and those persons who do not as identified in the Equality Act 2010.

The protected characteristics identified in the Equality Act are age, disability, gender re-assignment, race, religion or belief, sex, sexual orientation, pregnancy and maternity. Marriage and civil partnership is also included although only in respect of the requirement to eliminate discrimination in employment.

Training providers and employers MUST also comply with the other duty under the Equality Act 2010 to ensure that applicants are not discriminated against in terms of entry to the industry based upon those nine protected characteristics.

Apprenticeships in the sector aims to promote diversity, equal opportunity and inclusion by offering a high quality learning experience.

The delivery of the Apprenticeship must be in a setting free from prejudice and discrimination where all learners can contribute fully and freely and feel valued.

Employers/providers must be able to demonstrate their selection, recruitment and employment practices are in line with the Equality Act 2010 and there are no overt or covert discriminatory practices in relation to any of the protected characteristics.

### **Issues:**

Limited availability of teaching and assessment of specific skills.

### **Barriers:**

- Stereotyping still exists in the hair and beauty sector, which can limit the number of applications from all genders.
- Low initial earning potential for new recruits.
- Misunderstanding of the skill levels required and the complexity of those skills.

### **Actions:**

Habia seeks to use as many positive inclusive images and gender neutral language in its literature and publications as possible.

## **EMPLOYMENT RESPONSIBILITIES AND RIGHTS (ERR)**

Employment Rights and Responsibilities (ERR) are no longer a compulsory part of the framework. However, it is recommended that all apprentices (in particular, the 16 years -18-year age group) receive a full company induction programme which clearly outlines the rights and responsibilities of both employers and apprentices.

In addition, it is recommended that Foundation Apprentices (Level 2) aged 16-18yrs old, and adults that are new to the workplace, should undertake learning that includes their rights and responsibilities. This could be in the form of a recognised qualification such as a Level 2 Award in Employment Awareness in the hair and beauty sector, or completion of the Habia Employee Induction programme.

It is also recommended that Apprentices (Level 3) should undertake a Level 2 Award in Employment Awareness in the hair and beauty sector, or completion of the Habia Employee Induction programme, if they have not already achieved this.

## **RESPONSIBILITIES**

It is the responsibility of the Training Provider and Employer to ensure that the requirements of this pathway are delivered in accordance with the Welsh Government Apprenticeships Guidance.
